#### Who are we?

We are Abacus Edutech Limited, a UK based education software developer. We are here to support schools by using new ideas and innovative technologies that are designed to make managing school SEND departments easier.

## How do we collect information from you?

We obtain information about you when you use our websites, for example, when you contact us about products and services, from exhibitions and networking and from communications with our sales and support teams.

# What type of information is collected from you?

Depending on the service required, the personal information we collect might include your name, email address, job title, company address and phone number, IP address and information regarding what pages are accessed and when and any other information required to fulfil your request.

# How is your information used?

We may use your information to:

- respond to enquiries;
- to carry out our obligations arising from any contracts entered into by you and us;
- seek your views or comments on the services we provide;
- notify you of changes to our services;
- send you communications which you have requested or that may be of interest to you. These may include information about our latest software developments;

## How long do we keep your data?

We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information to fulfil our statutory obligations. We will hold your personal information on our systems for as long as is necessary for the relevant activity. This period may vary if we consider it necessary for good operational or commercial reasons, or in order to meet other legal obligations.

## Who has access to your information?

We will not sell or rent your information to third parties.

We will not share your information with third parties for marketing purposes.

Third Party Service Providers working on our behalf: We may pass your information to our third party service providers, agents, subcontractors and other associated organisations for the purposes of completing tasks and providing services to you on our behalf (for example to send you mailings). However, when we use third party service providers, we disclose only the personal information that is necessary to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own direct marketing purposes. Please be reassured that we will not release your information to third parties beyond Abacus Edutech Limited for them to use for their own direct marketing purposes, unless you have requested us to do so, or we are required to do so by law, for example, by a court order or for the purposes of prevention of fraud or other crime.

Third Party Product Providers we work in association with: We work with Wonde for the purpose of retrieving data from Organisations' Management Information Systems. We will only pass your information to them if and when you purchase a service from us and hence agree to our terms and conditions.
